

Your privacy is important to us. This statement outlines our policy on how we manage the personal information we hold about our customers, shareholders and others. It applies to IG Markets Inc and all organizations within the IG group of companies.

It is our policy to respect the confidentiality of information and the privacy of individuals.

Our Privacy Notice will be reviewed from time to time to take account of new laws and technology, changes to our operations and practices and to make sure it remains appropriate to the changing environment. Any information we hold will be governed by our current Privacy Notice.

## Why do we collect personal information?

Our business is to meet our customers' needs for a range of financial services. To do this effectively, we need to collect certain personal information.

## What kind of personal information do we ask for?

The type of personal information we may collect can include (but is not limited to) name, mailing address, telephone number, e-mail address, Social Security or Passport/Tax ID number, gender, birth date, education, occupation, marital status, trading experience, your approximate annual income, approximate net worth, and available risk capital to assess your financial position. We are required to collect some of these items of personal information according to law.

We obtain most of the information directly from our customers through application or other forms, and from maintaining records of information provided in the course of ongoing customer service. We may also obtain information from other sources.

If you choose not to provide the information we need to fulfil your request for a specific product or service, we may not be able to provide you with the requested product or service.

We may ask for other information voluntarily from time to time (for example, through market research, surveys or special offers) to enable us to improve our service or consider the wider needs of our customers or potential customers.

## How do we use this information and who may we disclose it to?

While we may send you marketing material from time to time that we think will be useful to you, we are conscious of the need to respect your privacy.

Unless you are informed otherwise, the personal information we hold is used for establishing and managing your account, reviewing your ongoing needs, enhancing customer service and products and giving you ongoing information or opportunities that we believe may be relevant to you.

Depending on the product or service concerned and particular restrictions on sensitive information, this means that personal information may be disclosed to:

- other companies within the IG group who provide financial and other services
- service providers and specialist advisers who have been contracted to provide us with administrative, financial, insurance, research or other services
- Referring Agents with whom we have a mutual relationship
- credit providers, courts, tribunals and regulatory authorities as agreed or authorized by law
- credit reporting or reference agencies.

Generally, we require that organizations outside the IG group of companies who handle or obtain personal information as service providers acknowledge the confidentiality of this information, undertake to respect any individual's right to privacy and comply with the Data Protection Principles and this policy. We do not sell, license, lease or otherwise disclose your personal information to any third party for any reason, except as described above, or as otherwise permitted by law.

## Management of personal information

We train our employees who handle personal information to respect the confidentiality of customer information and the privacy of individuals. We regard breaches of your privacy very seriously and will impose appropriate penalties, including dismissal.

We have an appointed Privacy Officer to ensure that our management of personal information is in accordance with this statement and the privacy laws.

## How do we store personal information?

Safeguarding the privacy of your information is important to us, whether you interact with us personally, by phone, mail, over the internet or other electronic medium. We hold personal information in a combination of secure computer storage facilities and paper-based files and other records, and take steps to protect the personal information we hold from misuse, loss, unauthorized access, modification or disclosure.

We may need to maintain records for a significant period of time. However, when we are no longer required to maintain records, or we consider information is no longer needed (which ever is longer), we will remove any details that will identify you or we will securely destroy the records.

## How do we keep personal information accurate and up-to-date?

We endeavour to ensure that the personal information we hold is accurate and up-to-date. We realise that this information changes frequently with changes of address and other personal circumstances. We can generally update your customer information over the telephone.

## What if you have a complaint?

If you consider that any action of ours breaches this Privacy Notice or otherwise doesn't respect your privacy, you can make a complaint. This will be reviewed promptly.
